ORDINANCE NO. 14-16

AN ORDINANCE TO REVISE THE CODIFIED ORDINANCES
BY ADOPTING REPLACEMENT PAGES, AND DECLARING
AN EMERGENCY.

WHEREAS, certain provisions within the Codified Ordinances should be amended to conform with current State law as required by the Ohio Constitution; and

WHEREAS, various ordinances of a general and permanent nature have been passed by Council which should be included in the Codified Ordinances; and

WHEREAS, the City has heretofore entered into a contract with the Walter H. Drane Company to prepare and publish such revision which is presently before Council;

NOW, THEREFORE BE IT ORDAINED by the City of Bellevue, Huron, Erie and Sandusky Counties, Ohio:

SECTION 1. That the ordinances of the City of Bellevue, Ohio, of a general and permanent nature, as revised, recodified, rearranged and consolidated into component codes, titles, chapters and sections within the 2016 Replacement Pages to the Codified Ordinances are hereby approved and adopted.

SECTION 2. That the following sections and chapters are hereby added, amended or repealed as respectively indicated in order to comply with current State law:

Traffic Code

335.021 Ohio Driver's License Required for In State Residents. (Added)

General Offenses Code

529.01 Liquor Control Definitions. (Amended)
529.07 Open Container Prohibited. (Amended)
537.051 Menacing by Stalking. (Amended)
537.10 Telecommunications Harassment. (Amended)

Building Code

Chap. 1301 Ohio Building Code. (Amended)

Fire Prevention Code

1519.04 Fireworks Possession, Sale or Discharge Prohibited. (Amended)

SECTION 3. That the complete text of the sections listed above are set forth in full in the current replacement pages to the Codified Ordinances which are hereby attached to this Ordinance as Exhibit A. Any summary publication of this ordinance shall include a complete listing of these sections. Notice of adoption of each new section by reference to its title shall constitute sufficient publication of new matter contained therein.

SECTION 4. That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, welfare and safety and for the further reason that there exists an imperative necessity for the earliest publication and distribution of current Replacement Pages to the officials and residents of the Municipality, so as to facilitate administration, daily operation and avoid practical and legal entanglements.

WHEREFORE, this Ordinance shall go into full force and effect immediately upon its passage by Council and approval by the Mayor.
